- 2. Support the Governor's Employment programs for all Floridians, School Transition programs for Students.
- 3. Identify and monitor funding opportunities to support families of individuals on the waitlist.
- 4. Identify and respond to external funding opportunities directly or by supporting other agencies.

# **Community Engagement & Partnerships**

#### **GOAL:**

Foster and strengthen partnerships with state, local and regional organizations to strengthen service planning, development and provision.

### **Strategies**

- 1. Strengthen our community through the development and support of statewide, regional and local networks, community advisory committees & community groups.
